
She spent all the day in his chair until finishing all the assigned work.



"If I can make you hot it is because I am very sensual"... and just like that, the opposite if the answer is the opposite.

Why are they flying monkeys at the service of narcissism?

When the narcissist comes into your life, he has already created an army of monkeys flying, contrary to the tendency to think that these are added or they simply "turn" into flying monkeys at one point in their lives. He narcissist has a secret life before meeting before meeting his victim

of him, and this secret life remains hidden by his army of monkeys that includes friends, family, and everyone who can help you so that you do not go out into the open. Light everything he has done and his personality.

Some of The reasons that drive these flying monkeys include:

### The Self-preservation and

protection. Leonardo's motivation to become her brother's flying monkey it was understandable and based on self-preservation. Like other people who do a narcissist's dirty work for them, she didn't pay much attention, if any, to the impact of her actions. Her need for Taking care of herself was far greater than her need to protect anyone. Another person. Defending the narcissist satisfies your innate need to feel valued and needed because of your role as rescuer.

<u>A loss of the sense of itself</u>. Some flying monkeys are so intimidated by the narcissist that they have much less ability than one would expect when it comes to distinguishing between good and bad. They may have experienced years of abuse emotional at the hands of the narcissist and have lost their sense of self and independent decision making along the way.

<u>Love the drama</u>. Some flying monkeys they really thrive on drama. When you are involved with a narcissist, it's almost inevitable that you'll get involved in some drama along the way. Which can overcome the adrenaline of being trapped in lies, secrets and deceptions?

By Therefore, to some degree, flying monkeys are narcissists who recognize themselves among themselves. Their peers and share some of their traits.

- ✓ 3.He believes that he is "special" and unique and that only they can understand him or only can relate to other special or high-ranking people (or institutions) status.
- ✓ 4.He has an excessive need for admiration.
- ✓ 5.Exhibits a feeling of privilege (i.e., expectations not reasonable grounds for especially favorable treatment or automatic compliance of your expectations).
- ✓ 6.Exploits interpersonal relationships (that is, takes advantage of others for their own purposes).
- ▼ 7.Lacks empathy: is not willing to recognize or identify with the feelings and needs of others.
- ▼ 8. You often envy others or believe that they are envious of him.
- → 9.Exhibits arrogant, superior behavior or attitudes.




way for years, on the contrary they added and invited people to my house without paying them anything and without warning and all at my expense.



What makes a person feel compelled to act in a certain way? Way they don't want to or to help when they don't want to or listen to other people's problems?

#### It's called FLYING MONKEY MANIPULATION.

The typical example is when in the situation of a motorist goes to park her car, a poorly dressed person appears and ungainly giving instructions that no one has asked of her, and then when she goes to Leaving the place where she has parked her car, he stands in front of her. Car and forces him with non-verbal language to give him money in exchange for the mere presence of her.

If you don't want to help someone you shouldn't do it, you shouldn't support any manipulative behavior, even if it is minimal, because it feeds the ego of a person with narcissistic traits.

Trojan horse: when the enemy gets into your house.

Narcissists have a wide range of coping techniques handling. We already saw many of them. And if you want to learn to identify each of these perverse maneuvers, you must know them all to know how detect them and defend yourself against them. Today we will focus on a subtle technique but very dangerous: flying monkeys. You've probably already had contact with their flying monkeys and you haven't even noticed, since these can dress up as close friends, family members who apparently want the best for you or even neutral people who seem impartial. In this book we will explore each of these variants where you can have the enemy hidden in your own home.

Let us begin. First let's see where the term monkeys come from. Flying anyone who remembers seeing the Wizard of Oz when he was a child you will probably remember how horrible they were the flying monkeys of the Wicked Witch of the West. These monkeys they were sent by the witch to do her dirty work. And since then the phrase has become synonymous with people who end up doing the work Dirty of a narcissist. Are flying monkey's people who act in favor of the narcissist, whether we are aware of it or not? They are your servants. The bad thing is that many times they do not know that they are. They often get caught up in the plan of the narcissist carrying information from one place to another. But there are also flying monkeys who are direct accomplices of the



narcissist. This could be because they admire him and want to help him, or because they want to hurt you and take advantage of the opportunity. Next I will show you the three types of monkeys flying ones that exist.

Flying monkey evident. This is that person close to the narcissist. It can be up to your best friend of his or someone in his family. That person will approach you to try get information out of you or plant some false information in an attempt to manipulate you These flying monkeys are very obvious, so they are the most easy to detect.

Naive flying monkey. They are people who have contact with the narcissist and they don't know they are being used. They may be part from the circle of friends, the work environment or the family. They are people who they have a common bond with you. That is why the narcissistic person will take advantage of this connection to her advantage and plant false information without her this person realizes this. You can tell him that you are sad, that you have a serious illness or anything else, something that is sufficiently important so that that person feels that they have to tell you or that you need know it. This person does not usually act evil; he simply gets tangled because of the narcissist's lies and manipulation. It should be noted that the person narcissist in question begins his smear campaign against you from the beginning of the relationship, generating doubts in your close circle about your behavior, giving them false information that they cannot contrast to make you look like someone unstable, toxic or toxic. That you are with every time more paranoia and that he is worried about the way you act. That you are an alcoholic or addicted to some drug, that you have some type of mental disorder such as bipolarity, borderline or other that are the most common. In this way it will generate a perfect breeding ground for those same people to later believe that it is a good person, who cares about you and who did not deserve to go through all that you supposedly did to him and that you are a bad mother, unfaithful, toxic, violent, liar, lazy or lazy and that you do not contribute to the home financially or that The narcissist simply keeps the house afloat. Thus, the flying monkey naive person will believe that he is doing you good. If he tries to fix things among you, you will want to give them a second chance, so you can speak well of that person, tell you that he is suffering and that he really cares wants, that you should be more patient and understanding, and even may tell you that you should give him another chance or that you should help him in this difficult time you are going through. Probably not meanly, but you must be very careful because that person can make you doubt. Even in a moment of weakness or relief, you can tell him/her intimate things that hurt you or make you feel bad, or provide you with any other type of information, which can be

extracted by the narcissistic person, who will manipulate the flying monkey naive to tell him everything. Be very careful who you tell your things to personal. The best thing is to tell him not to tell you about that person and if he doesn't understand and continues doing it, you should keep him out of your life too. Don't mess with Trojan horse in your life. You don't have to have the enemy at home.

Hidden flying monkey is the most dangerous and treacherous of all. He is someone very close that you never see coming. Someone you trust and you don't even imagine that he can be on the narcissist's side. It may be a best friend or a family member whom you trust a lot and who has fallen into trap. The smear campaign we talked about earlier may have deep impact on people even very close to you. Narcissists use a portion of true information and then modify it, exaggerate it and convert it into something new to make you look bad. But that bit of truth that includes lying can make victims doubt their manipulation by identify that behavior in you, which generates credibility and they end up believing everything else. For example, you may be a somewhat jealous. Then the manipulator includes that part of truth in his stories and He exaggerates it and invents things that never happened, justifying those they did not they know how you get when they're alone, that you show a face that they don't. They know and you go crazy with jealousy and rage. This can be applied to many others. Traits of your personality. We all have flaws, but the manipulative person it enhances and magnifies them, which is unverifiable because it is excused that You do it in private and this can make even your closest circle doubt, since he appears to others as a kind, understanding, loving person and respectful, so it generates trust and even seems like an ideal person, which puts the responsibility on you. Of course the hidden flying monkey it can also be someone close. Someone who finds the reasons I was looking to release his hidden grudge against you. Maybe take advantage of ally with the narcissist and in this way cause very mental confusion. Dangerous. It could be a friend who secretly envies you, a family member who bear a grudge or jealousy towards you, it could be the person you least expect and that's what more dangerous. You must pay close attention to their true intentions, but mainly you have to set your limits very firmly.

Make it clear to whoever makes you doubt that you don't want to know nothing about that person that they don't talk to you about them, that you don't want to know anything more. If someone does not respect this point, remove them from your life too. Whoever the person, who loves you, respects your limits and your personal decisions? Take care of yourself a lot of who you trust. Final summary. The narcissistic person cares too much public image of him. This is why she built an impeccable image in your group of friends and family, so that later no one believes you when they say explain what you are going through. When your loved ones bring you false information from the narcissist, they actually do it because they think it wills they are helping, because they swallowed his lies, they bought his false image ideal and they became flying monkeys without wanting to or knowing it. In this case, you should talk to them seriously and explain what is happening. Yeah they don't do it maliciously; they will understand and respect you. Otherwise, you must stay away and have zero contact with them too, because they have already become extensions of the narcissist. Don't waste your energy on them. It is important keep them away because they can use very dangerous techniques on you such as gaslighting or encouraging the narcissist's ubering. In my case I in September 2022 after of almost 2 years studying this topic in depth, and being aware of what that had been happening since the Monstruo Huacho left, having knowledge of everything their actions, I began to recognize these patterns (of flying monkeys) in my friends, my family, clients, and employees. What they don't know (everyone we mention in this chapter) They thought I didn't notice their questions, their tones, and their intentions and in

truth I let them advance with their narrative and see until where his limits of betrayal reached, he even lied to them in the answers and I always answered what they wanted to hear, I always saw them as people of mediocre intelligence and very basic reasoning, which is why I tried to this way, and they didn't realize that I managed them and not the reverse. For this reason, on the date that I designated as the deadline (September 2022) I called them all and each one in an orderly manner to communicate exactly the same thing to everyone: "The reason for my call is to tell you that I have decided to block you from me. cell phone, my emails and all forms of communication because you don't give me You contribute nothing positive in my life and at the same time I leave you the invitation open with open arms for when you decide to abandon your attitude and contribute in a positive way to resume contact, before NO. See you later. "(Cutting off communication, blocking him from my social networks and cell phone). The day Before I had made this radical decision it was because the last flying monkey Leonardo Molina Ruiz (see description above in this chapter) in September 2022, knowing that on December 1, 2021, the narcissistic Monstruo Huacho had taken my daughters, and this flying monkey, knowing what was happening to me, did not contact me for all the time the narcissist was torturing me making it impossible for me to see and be with my daughters, and what was my surprise when receiving this call as if nothing had happened during that year of his absence and making me understand with His story that I was in perfect condition was beyond all logic. Of I am immediately bombarded with questions like a police interrogation, as if he were reading a guideline, as if someone was dictating in his ear what he had to ask me or know about me. During his interrogation I interrupted him half because I got tired of his charade and started applying everything I learned about narcissists and their flying monkeys, for example, I confronted his absence of him, how false his questions were, how little of a man he had been, how bad friend of his actions, and how cruel and selfish he was by not empathizing and not doing no questions related to how I felt with all the avalanche of violence to which the Monstruo Huacho had subjected me, I proceeded to throw away his monkey masks telling him clearly that he was a puppet of the Monstruo Huacho, that he finished his performance worthy of an Oscar and that he will stop lying because I don't I believed nothing he said, after many attempts to continue insisting and Disrespect my intelligence, he realized that he no longer had his mask put on, and he showed his true criminal face and went from treating me like "lady" or "friend" to tell me that I was a "prostitute", "whore", "crazy" and other expletives because he was discovered. After this I cut off the call and I was left alone as a frustrated flying monkey.

This is the way to confront and take down the monkeys flying, for this you must educate you and learn everything about the sick mental disorders with disorders such as narcissism, psychopathies and all types of syndrome. Don't forget to educate yourself more about narcissism to continue learning and avoid getting manipulate

Con fecha 19 de julio del 2023, doña Francisca solicita evaluación psicológica debido a múltiples afectaciones emocionales y ansiosas de larga data que se manifiestan a nivel personal. Además, su aparición coincidiría con problemáticas vividas en su relación de pareja, en la cual relata que habría sido víctima de Violencia Intrafamiliar.

#### ANTECEDENTES CONTEXTUALES

Con respecto a la historia familiar, en el año 1998 doña Francisca Jáuregui (20 años) conoce a don Cristian Marfull (27 años) por medio de una amiga en común. Luego inician una relación amorosa y al cabo de 3 meses, don Cristian se habría mudado a la casa de doña Francisca en la comuna de Ñuñoa, quien tenía 2 hijas de su anterior relación, Jazmín y Francisca. Al cabo de 3 años de relación, don Cristian habría convencido a doña Francisca de contraer matrimonio.

Según relatos de doña Francisca, desde los 3 meses de relación que se preocupó de solventar y apoyar económicamente a su pareja; le habría pagado una carrera universitaria (Kinesiología), le habría comprado un auto (ya que él le decía que se sentía avergonzado de no tener un vehículo para movilizarse a su universidad) y creó una sociedad con ganancias iguales llamada Tecmeseg, de la cual paciente refiere no haber recibido dinero.

En el año 2005, doña Francisca refiere haber descubierto que su marido no estaba cursando quinto año de universidad, como él le decía, sino más bien se encontraba en segundo, ya que no habría pagado las mensualidades que ella le entregaba para solventar la carrera. A propósito de esta situación, doña Francisca conversa con don Cristian sobre lo sucedido y éste habría dejado una carta informando que atentaría contra su vida, por lo que ella interpone una denuncia en Carabineros por presunta desgracia, ya que desconocía su paradero en ese momento. Al cabo de un rato, don Cristian habría llegado al domicilio y se habría desmayado, por lo que lo envían a la Clínica Ñuñoa, para luego ser internado durante 2 meses por un diagnóstico de Depresión Mayor.

Es loable mencionar, que paciente refiere que en reiteradas oportunidades habría sido manipulada por su marido, quien le decía frases como: "soy un inútil", "soy un tonto", con el objeto de que ella accediera a las peticiones de él y lo solventara económicamente.

Durante el año 2009, según relato de doña Francisca, a raíz de una discusión sostenida con su marido, éste junto a su hermana la habrían trasladado a una clínica, con el objeto de ser atendida por un psiquiatra quien en una sesión la diagnostica con Trastorno de la Personalidad Bipolar y le receta medicamentos, que don Cristian manejaba y se los administraba 3 veces al día, por lo cual, ella desconocería la farmacología que ingería, sin embargo, refiere "me sentía dopada, funcionaba en piloto automático", "me daba como 10 pastillas al día".

Durante ese mismo año, refiere que don Cristian estaba a cargo de pagar los dividendos de la casa, hecho que no habría ocurrido y trajo como consecuencia el remate del inmueble por dicha deuda.

Cabe destacar, que desde el año 2010, paciente relata que habría sido presionada constantemente por su marido, el cual ejercía violencia psicológica con frases tales como: "tu

mamá no te quiere", "tus amigos no te quieren, estas sola", "tus hijas te odian porque pasas trabajando, deberías quedarte en la casa para cuidar a tus hijas", entre otras cosas.

En el año 2015, doña Francisca relata un episodio en el cual ella descubre una página de "escorts" en el computador que manipulaba don Cristian, al cual confronta y él reconoce, situación que provoca que doña Francisca le informe sus intenciones de abandonar el hogar. Esa noche se va a dormir y al otro día habría despertado en la clínica Los Andes en la que estuvo internada durante 1 mes, según relato de su marido ella habría intentado suicidarse, sin embargo, ella refiere no recordar ese suceso.

Es importante señalar, que entre el año 2015 al 2019, doña Francisca refiere "viví una pesadilla con muchas lagunas", descubre que le habrían aplicado el método del electrochoque durante 3 meses en la clínica Ñuñoa sin su consentimiento, que su marido le habría sido infiel en múltiples oportunidades, que le habrían robado dinero de su cuenta bancaria, entre otras cosas.

Durante el año 2019, según relato de doña Francisca a raíz de una discusión por unos mensajes de escorts con don Cristian, él se lleva a sus hijas a Temuco sin su consentimiento y pasa 8 días sin saber de ellas, ya que su marido no atendía las llamadas. Situación que provoca una descompensación emocional, donde es llevada por una amiga a la clínica Alemana. Al enterarse don Cristian, acude al recinto para nuevamente decirle al médico que ella habría atentado contra su vida (hecho que doña Francisca niega), provocando que sea internada en la clínica Los Andes.

Cabe destacar, que paciente refiere que con fecha 01 de septiembre del 2020 se produce el quiebre definitivo del matrimonio, donde su cónyuge abandona el hogar.

Durante el año 2021, ocurre un episodio de violencia, en la cual doña Francisca relata que don Cristian la habría golpeado y acusado en Carabineros de haberlo agredido con un cuchillo, donde decretaron orden de alejamiento y tratamiento psicológico. Sin embargo, don Cristian le refiere que en el tribunal habrían decretado que ella debía ser internada en un centro, hecho que doña Francisca al tiempo después se entera que no era real, al ver el acta de audiencia.

Debido a lo anteriormente expuesto, es que don Cristian junto a su hermana trasladan a doña Francisca en contra de su voluntad, al centro de Rehabilitación Carácter Chile ubicado en la comuna de Melipilla, en la cual estuvo internada durante 6 meses y relata haber sufrido violencia física y psicológica por parte de las compañeras. Al regresar de Melipilla, refiere que retoma la convivencia con su marido, ya que él le decía que estaba bien y al otro día, don Cristian le dice que comience a trabajar en la peluquería, que necesitaban dinero.

En diciembre del 2021, doña Francisca refiere que don Cristian vuelve a desaparecer con las niñas, diciéndole por medio de un mensaje telefónico "esto es tu culpa, te dije que te iba a pasar esto si no acatabas mis órdenes" y luego la bloquea. Con el paso de los días, doña Francisca refiere que comienza a recibir videos de sus hijas de distintos números telefónicos, con mensajes "las niñas son felices, no te necesitan", "matate mejor, porque nadie te necesita" "hazle un favor a

tus hijas". Situación que habría provocado que doña Francisca cogiera unos medicamentos con la intención de suicidarse, por lo que durmió durante 4 días.

En mayo del 2022, doña Francisca sube a sus redes sociales un video solicitando ayuda, debido al desconocimiento del paradero de sus hijas y por no poder contactarse con ellas. Hecho que provoca que don Cristian se contacte con ella por medio de su hermana.

En junio del 2022, paciente relata que su marido la lleva al hotel Ibis y la mantiene retenida en contra de su voluntad durante 3 días, luego don Cristian desaparece hasta la actualidad.

Cabe destacar, que con fecha 04 de diciembre del 2021, doña Francisca interpone una denuncia por VIF, en mayo del 2022 se realiza la audiencia en la cual habrían decretado "maltrato habitual".

Es importante mencionar, que doña Francisca refiere que no ha podido contactarse con sus hijas y desconoce su paradero desde diciembre del 2021 hasta el día de hoy. Por temor a que algo les suceda a sus hijas no ha intentado buscarlas para traerlas de regreso.

Por último, al indagar estado emocional actual de la paciente, se pesquisa sintomatología ansiosa que aumenta al recordar y narrar aspectos asociados a las dinámicas violentas en las que estuvo expuesta.

#### RESULTADOS EVALUACIÓN

En relación a los resultados obtenidos por medio de entrevistas semiestructuradas y aplicación de instrumentos, se puede señalar lo siguiente:

En cuanto a aplicación de Inventario de depresión de Beck y Examen Mental, es posible referir que doña Francisca presenta sintomatología de larga data que incluyen sentimientos de fracaso, sensación de estar siendo castigada, sentimientos de culpa, anhedonia, alteración en el sueño, autocrítica excesiva, sensación de culpabilidad, dificultad para llorar, fatiga, cansancio y ansiedad somática (sensación de ahogo, dolores de cabeza, ritmo cardiaco acelerado, sudoración excesiva, malestar en el pecho, mareos, sensación de cosquilleo, sensación de extrañeza respecto a si misma y estremecimientos).

En cuanto a aplicación de Escala de Gravedad de Síntomas del Trastorno por Estrés Postraumático, es posible inferir que doña Francisca presenta sintomatología asociada a Trastorno por Estrés Postraumático Crónico, vinculado a episodios de violencia de la que fue víctima por parte de su ex pareja y que incluyen: re experimentación de recuerdos desagradables y recurrentes del suceso basados en imágenes, pensamientos o percepciones que se presentan

como si el hecho de violencia estuviera ocurriendo nuevamente, acompañados de malestar psicológico y fisiológico al exponerse a estímulos que le recuerdan el suceso de violencia, sumado a sueños desagradables y repetitivos sobre lo vivido; síntomas de evitación donde debe realizar un esfuerzo para ahuyentar pensamientos, sentimientos o conversaciones asociadas al suceso de violencia, así como también tiende a evitar lugares, situaciones o personas (ex pareja) que le evocan el recuerdo de lo sucedido, experimentación de distanciamiento respecto a los demás, observa una disminución marcada del interés por cosas y actividades significativas para ella y con respecto a su futuro, siente que lo sucedido le ha afectado negativamente. Por último, se presenta un aumento de la activación que incluye dificultad para conciliar y mantener el sueño, dificultades de concentración, se encuentra excesivamente alerta y se sobresalta más fácilmente desde el suceso de violencia vivido.

#### CONCLUSIONES

De acuerdo a los resultados obtenidos, es posible referir que doña Francisca Jáuregui presenta indicadores sintomatológicos asociables a un Trastorno Depresivo Moderado de larga data, a raíz del daño emocional crónico asociado a haber estado expuesta a episodios de violencia intrafamiliar históricamente durante su matrimonio.

Además, doña Francisca presenta indicadores sintomatológicos ansiosos de larga data asociables a Trastorno de Estrés Postraumático Crónico Grave, como consecuencia del daño emocional vinculado a la violencia intrafamiliar, que se configuraría como un suceso traumático.

#### SUGERENCIAS


En virtud de la evaluación realizada se sugiere:



#### 5.4 DESCRIPCION TEORICA

8A PASIVO AGRESIVO Relacionándose con los demás de una manera obsequiosa y autosacrificada, estas personas permiten, y quizás fomentan, que los demás les exploten o se aprovechen de ellos.
