**THE PEOPLE'S Lawyer: Narcissistic Lawyer, Con Man and Pedophile**

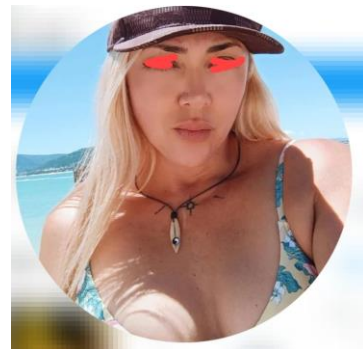

The lawyer's wife was ill and had two daughters.

In view of this, I advised her that her husband rent an office in Gran Avenida, Santiago, Chile. I told the wife that I could also help her with CLP \$200,000.- two hundred thousand pesos additional and I told her to set up company that I did to keep the monster huacho busy, a company called Tecmeseg. He convinces his clients over the phone with calls telling them lies, giving them false hope and the clients paid him from CLP \$80,000 to CLP \$450,000 (which we will see later in the claims=) to get flaites out of jail. 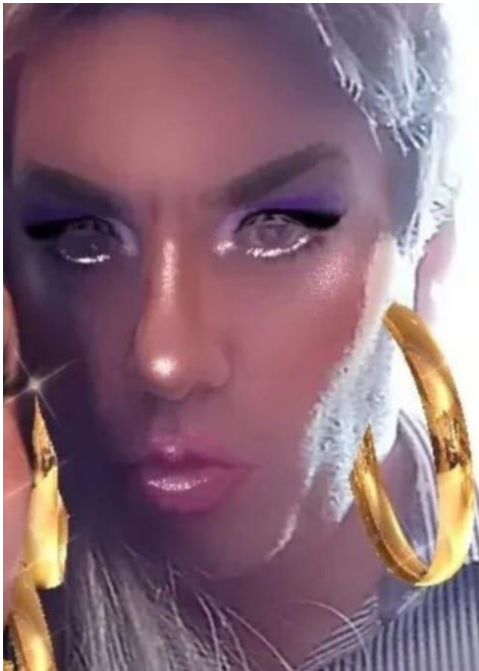

The narcissist knows very well when to motivate and when not to, it's like giving the thread and pulling it when it's due. Thus the narcissist retains all control, and in this case the people's lawyer does not realize that he is a puppet of the narcissist. It seems to me the last

straw that he still trusts a traitor, since the Monstruo Huacho has never kept his word to anyone, he never paid his debts, he spent all the money he received, it was not enough to pay for school, bills, his own university, cars, and even the furnishing of his own office I had to do. How does anyone believe that the Monstruo Huacho is going to make an exception and fulfill a promise to a stranger if the narcissist was not able to fulfill to his own family that they were there when he was wrong?

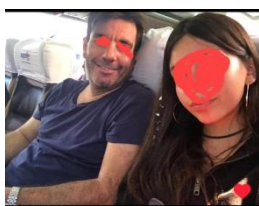
cognitive-dissonance, and it is based on the pure hopes and false expectations that the Monstruo Huacho implanted in you, in a mind as weak as yours.

### Complaints and lawsuits

In 2019 While we were friends and as I related above, as I was kind to his family, this lawyer left every day using my car, went to family courts in Colina and moved forward with the necessary procedures to take away the personal care of my daughters and give them to the monster huacho, they modified the email of the court so that I did not receive notifications, And they did everything they could to do everything behind my back and I wouldn't know what they were doing. When the Monstruo Huacho took my daughters, I found at least 20 paper notifications that the Monstruo Huacho had stored in his possession.



In January 2022, the people's lawyer sent a letter to the Colina guarantee court to remove all my furniture from my house. When the actuary called me, they couldn't remove any of my furniture and I only agreed to remove the electric battery and the girls' clothes, and I recommended that they hire a motoboy to remove those few things and not send trucks with polices because my furniture stays where it is.

In the same month of 2022, this lawyer filed a criminal complaint against me for attempted murder of the Monstruo Huacho, and his brief says that I went with a knife to Apoquindo's office to the Monstruo Huacho's office and that his secretary Laura Astorga saw me attack him with a knife as a witness. This case was closed for blackmail. People's lawyer, how did you take so long, pathological liar.

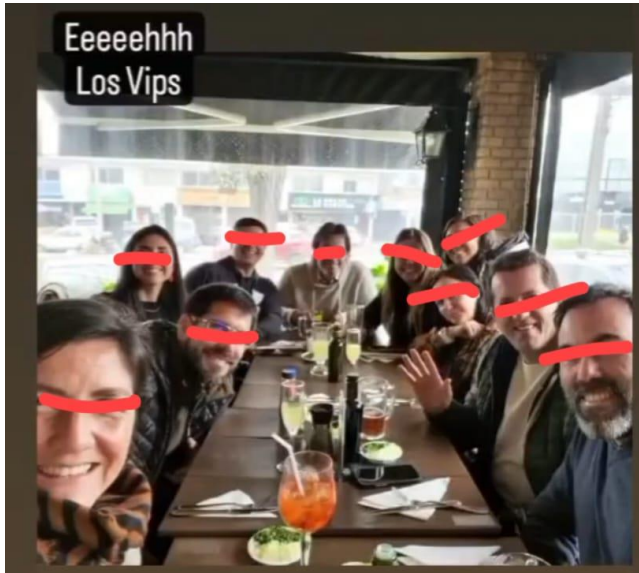

He arrived at 3:36pm and called me 12 times on the way telling me "I have a surprise for you" "get pretty" "get ready because we are going out", the Monstruo Huacho was euphoric and did not stop talking and of course, he was drugged. We went to the Dek pub in Chicureo, he bought 8 chocolate volcanoes, he didn't eat anything, and he wouldn't stop talking to the waiters because the drug had gone to his head that afternoon. The next day we were playing cards with Nina (his wife), the daughter, the Monstruo Huacho, the people's lawyer and me, and then in a childish and prepared way the Monstruo Huacho says to the people's lawyer (who happened to have a computer on the table): "People's lawyer, how do you get married again?" "Well, we're going to celebrate 20 years of marriage" to which the lawyer replies "it has to be annulled, it takes me 2 minutes to annul them because to get married again you have to annul them".

}I replied "I'm not going to annul this marriage, since this is just a party, this is only a symbolic ceremony" to which the Monstruo Huacho replied "yes, lawyer, and if it can be annulled since our civil marriage address is false". I said, "Understand. Do you think I didn't realize what's going on



here? All this deception that you are doing here, I'm not going to sign anything. They think I'm so stupid that I'm going to sign something and as soon as I've signed this monster is going to kick me out of my own house!" (This is the people's lawyer: a lapdog who, wagging his tail at a narcissist, devoid of all morals, a Machiavellian narcissist, falls so low that he forgets everything I did for his family lawyer without thanking anything). (because I've never seen her cry), and she replies, "My daughter, the eldest P.... she was abused" and then a silence, I told her "What!!" after another long time with a corkscrew I was able to get the little information he gave me about it, he told me that it had been an uncle, he did not want to tell me his name, nor did he tell me where although I asked him, after a while he told me that it was an uncle from Rancagua, I asked him when and he didn't answer me and then I said "was it last year? Because Tere Astorga told me that your daughter tried to commit



suicide and I made her call you again to warn you that it is very likely that your daughter was abused and you replied that the P... She had nothing, that she was envious of her sister because she had light eyes and was thin and that she only attracted attention because she was jealous and didn't answer any other questions. I asked him, "Is the culprit accused? Is he in prison?" and after that, he says "No" and when he realized that he already had a lot of information on the subject he did not want to give more information and ended up saying that "we already talked about it with the person, and it was an uncle" and when asked where he said "We talked in a square in Rancagua and all this was left there". When commenting on this abuse of the Monstruo Huacho after they left on

Sunday, he said, "I always knew that the people's lawyer abused the P... 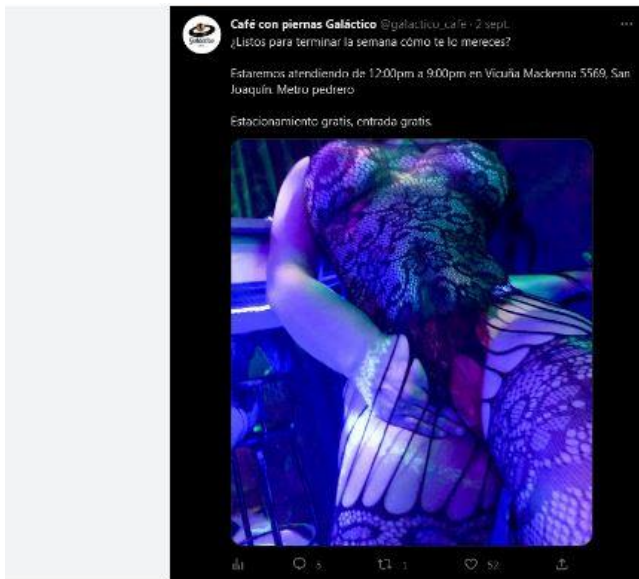



On January 3, 2020, a contract for the provision of services (lawyer) was signed to represent me and request a company to return money withheld as guarantees for work performed. The following payments are made to the lawyer: 150,000 (Pie to start case) lawyer does not deliver service ticket60,000 (Demand Notification) lawyer does not deliver service ticket60,000 (Demand Notification) lawyer does not deliver service ticket70,000 (Demand Notification) The lawyer is required to deliver service ticket. Send ticket and disappear. The lawyer, upon reviewing the documentation, indicates that the case is a won case since he investigated the company and found lawsuits for the same situation. The lawyer, after losing the case for not studying the documentation sent, informs that he must notify again to the company to file a new lawsuit. The lawyer is informed that he should never have lost the case since all the information and evidence ordered were given to him and that he had indicated that the case would not be lost. The lawyer insists that this is how these cases are handled and requests money again to notify the company. After making the last payment of 70,000 (Last notification) and insisting on sending the service receipts, the lawyer disappears, stops responding to the email, phone calls and WhatsApp messages. The bar association was contacted to record the situation and they reported that the lawyer does not belong to the bar

record the situation and they reported that the lawyer does not belong to the bar association. Then the information of the rut where the deposits were made is reviewed and the rut does not correspond to the lawyer's rut. The lawyer's ID appears in the contract for the provision of services (14.099.xxx-x). The money was deposited to the current account associated with ID 15.738.xxx-x (Valeska Miguelina R. Nuñez). It is recorded in sernac , SII for tax evasion and in the eastern prosecutor's office. Similar claims are found, that is, the same operation in the \*\*\*\*\*s.

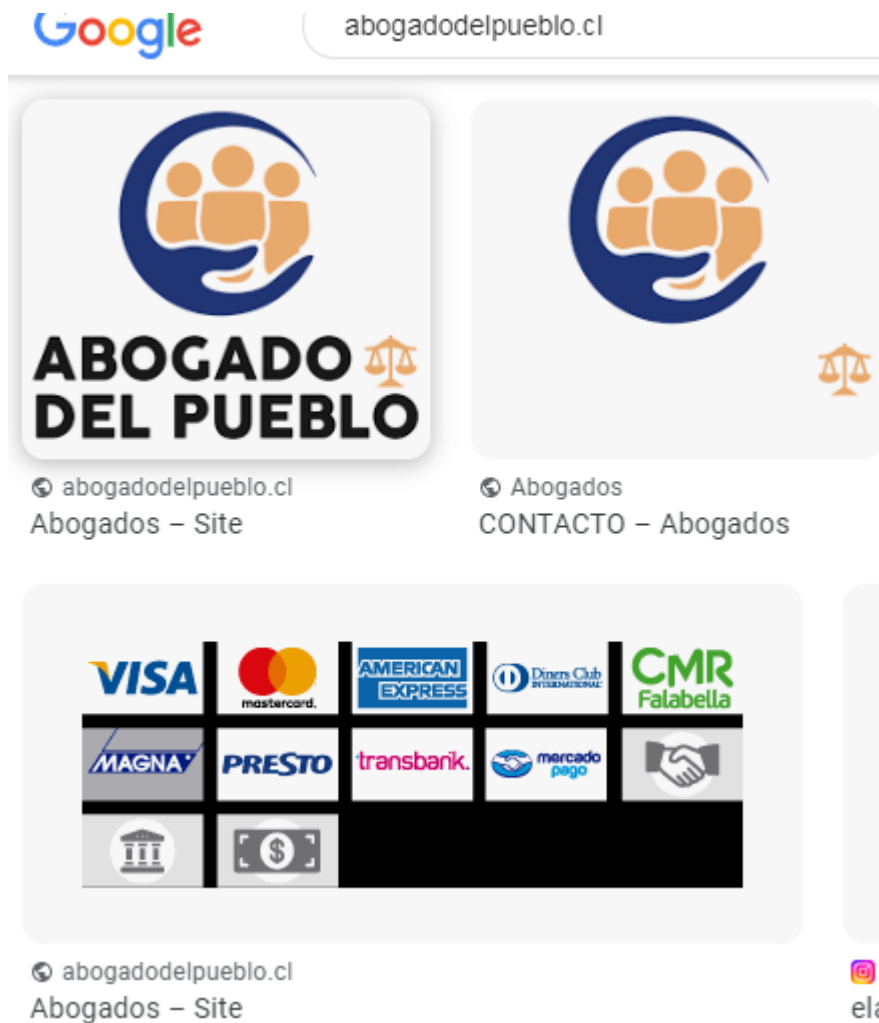
